PRIVACY POLICY

This Privacy Policy is effective for all users of the budgetcorporate.com website (hereinafter, "User"). The purpose of this Privacy Policy is to provide you with Budget Corporate Services Pte Ltd's (hereinafter "BGT", "we", "us" or "our") information collection practices (including the information BGT collects, how it is collected, and the circumstances under which the information is disclosed).

The following discloses our information gathering and dissemination practices for the website budgetcorporate.com:

SECURE SITE

Our site uses an online e- form for customers to apply. When your order is placed through our secure online server, or you send us an email, we collect confidential customer information. The secure server software (SSL) encrypts all order information you input before it is sent to us. When you send us an email (as distinguished from a secure e-form, which is encrypted), it is not necessarily secure and is not encrypted. All of the customer data we collect is protected against unauthorized access.

PERSONALLY IDENTIFIABLE INFORMATION

The customer information that is collected to process your order might include contact information (name, mailing address, telephone number, fax number and/or email address); corporate information (business name and description of business, information regarding directors, officers, shareholders and registered agent and information regarding shares and par value); and financial information (bank account, name on account, credit card number and expiration date), depending upon the nature of your order.

The contact information, corporate information and financial information from the e-form are used to process your request. The customer's contact, corporate and financial information is private and confidential. All information is secured and maintained on-file in our corporate office and is sometimes used to contact the customer for purposes of completing the services requested by the customer. Financial information that is collected is used to bill the customer and this information is not shared with anyone outside of our company, except the merchant bank for the processing of credit card orders and the offices of Government Authorities (such as Accounting and Corporate Regulatory Authority (ACRA) and Inland Revenue Authority of Singapore (IRAS)) to which the requested documents will be submitted.

REVIEW & CHANGES TO PERSONALLY IDENTIFIABLE INFORMATION

Our hosting service logs IP addresses, browser types and referred logs, which are used by our marketing staff for internal purposes only. Users email us at customerfirst@budgetcorporate.com to remove contact, corporate and/or financial information from our databases and to not receive any future communications from us or to change or modify any contact, corporate and/or financial information previously provided to us.

DISCLOSURE TO OUTSIDE PARTIES

Aggregate statistics about our customers, sales, traffic patterns and related site information may be provided to reputable third parties, but these statistics contain no personally identifying information. However, BGT may release client account information when we believe, in good faith, that such release is reasonably necessary to comply with law, prevent fraud, enforce or apply the terms of any of our user agreements or to otherwise protect the rights, property or safety of BGT, our customers or other third parties.

COOKIES

BGT may use outside companies to display ads on our site. These ads may contain cookies (pieces of information that a website transfers to an individual's hard drive for record keeping purposes while at the site). While we use cookies in other parts of our site, our ad company collects cookies received with banner ads and we do not have any access to this information.

THIRD PARTY LINKS

This website may contain links to other sites operated by third parties other than budgetcorporate.com. We are not responsible for the privacy practices or the content of such third party web sites.
